At a Meeting of Ashdon Parish Council held on Monday 9th May 2022 in the Baptist Schoolroom at 7.30pm.

1. Apologies for Absence

Cllr, Martin Foley (ECC), Cllr. James De Vries (UDC)

2. Election of Chairman for the Civic Year 2022/23

Resolved - that Cllr. Elsey be elected Chairman for the Civic Year 2022/23 (Cllr. Hayler)

3. Election of Vice Chairman for the Civic Year 2022/23

Resolved - that Cllr. Smith be elected Vice-Chairman for the Civic Year 2022/23 (Cllr. Player)

4. Public Representations

Mrs. Sue Patrick, Chairman of Ashdon Flood Group, said that she had been contacted by several members of the public regarding the installation of the drainage pipe from the development at Radwinter Road to the Bourn in that it was not as per the planning consent and that the extra discharge to the river could cause flooding problems in the village. The promised meeting with the developer's drainage engineers had not been held and so residents concerns were not able to be raised. She also noted that tarmac having been laid at the entrance at Radwinter Road was also not to the agreed plan to and that the lack of provision to take the water into the road drainage system would mean water would run straight down the road causing problems particularly outside White Horse House/Wittenham Cottage.

The Parish Council's letter to the developer was read, out also that to Councillor De Vries. The reply from the developer was also read out. The Parish Council were endeavouring to get satisfactory answers to the points raised but were having difficulty in doing so. The matter would be pursued via the District Council.

5. Short address by Cllr. Martin Foley on County Council matters

The following report was tabled in Cllr. Foley's absence:

Highways

I have asked Rissa for an update on outstanding matters for Ashdon. Should be available by next report.

One other thing, I have complained about local road closures, lack of notice , wrong signage Etc ;

ECC and other agencies have to work better at this and they are reminded regularly that this must get better.

Grants

Essex Locality funds... For 2022/2023 there will grant available subject to approval. (Possibly something towards further flashing speed sign?). Come through me.

<u>Crime</u>

Uttlesford Crime Reports attached 4 April to 1st May attached.

These do not include some Highways Crime Reports such a stealing of Iron Road Drain Covers.

Hot off the press... is that catalytic converters are being stolen again in numbers.

Covid Update

The purpose of this update is to provide my Parish Councils with a final update on the current Covid situation in Essex. I had previously stopped sending these earlier in the year, as the incidence of Covid receded. Following the recent spike in cases, I had resumed circulating occasional updates. Following today's, I am proposing to stop sending them unless there is a significant change.

Attached is a short selection of data for the last week. Key points to make are:

- There has been a 30.3% decrease in the Essex case rate in the last seven days, to 300 cases per 100,000. Decreases are being seen in all of the 12 districts, and all of the age groups as per the attached slides. Reference is made to stated rates as we recognise that many people testing positive are not submitting the results. Changes in the current testing regime may also be impacting the case rates.
- As of yesterday, there are 307 people in hospital in Essex with Covid compared to 394 people this time last week, representing a decrease of 22%. Again, I would stress that the majority of these will be in hospital for other reasons, who are then found to have Covid.
- Visiting restrictions in hospitals, as set out in previous e-mails, remain in place.

6. Short address by Cllr. James De Vries on District Council Matters.

The following report was tabled in Cllr. De Vries absence

Butlers Lane

UDC Enforcement have now been informed by the owner that he is disputing the assessment by UDC to class their actions as an unauthorised development. Enforcement has advised me that they are expecting his full written response by the end of next week.

Should Enforcement not receive said response, they will consider what action to take.

Going by the history of this case, I imagine the owner is going to submit a considerable amount of documentation again, which unfortunately will take UDC officers time to review and assess.

I will keep you updated as soon as I hear anything further.

Radwinter Road

I have been contacted by several residents as well as the Parish Council regarding several concerns relating to the drainage of water from the site as well as the positioning of the entrance.

This has been taken up with the UDC planning officer and I am currently awaiting a response.

UDC Council Update

In Aprils UDC Council meeting, the council resolved to approve 4 recommendations made by the planning working group.

A notable change includes a reduction in the call in period from 5 weeks to 4 weeks of the validation date.

The council also approved a motion to support the petition launched by ADSO and LLG on 5 January 2022 regarding giving councils discretion in future to hold remote and hybrid meetings alongside in person meetings.

Uttlesford District Council has taken the decision to amend the Local Plan timetable. The first draft Local Plan - known as the Regulation 18 Local Plan - will still go out to public consultation in the summer. **Consultation** (subject to Full Council approval) Monday 20 June to Friday 29 July

- c. Speeding. Councillor Moran reported that it was hoped to get a 20mph limit throughout the village in addition to that already outside the school. This would be investigated by Highways.

Councillor Hayler reported that bookings were going very well. The floor in the main hall had been refurbished. One quotation had been received by the hall committee for the upgrade of the fire detection system (three would be required)

- N.B. Councillor Moran joined the meeting at this point.

Mrs. Melanie Horrigan reported that the plan was now with the District Council and that a Mr. Ashcroft had been appointed by the NHP Group as the inspector. It was hoped to hold the final referendum in the late summer.

Councillor Hayler said that the white railings in the village needed painting, preferably before the Jubilee. The Clerk would seek to have this done.

Councillor Moran would contact Mr. David How (Windmill Trust) re siting of the beacon and cutting of the hedge round the windmill to afford a view of the beacon from the village. (Action Cllr. Moran)

The Chairman gave his thanks to the three ladies; Victoria Moriarty, Mary Green and Lizzie Green for their great help and enthusiasm in arranging the events for the Jubilee

The Clerk had emailed the tree officer at the District Council (29/4) with the Parish Council's response to the matter of taking ownership of the land at the "Fir Trees". No response to date.
