At a Meeting of Ashdon Parish Council held on Monday 6th November 2023 in the Village Hall at 7.30pm.

Present.

Councillors Mike Elsey (Chairman), Ms. Jane Gray, and Mrs. Michelle Lee

1. Apologies for Absence.

Apologies for absence had been received from Cllrs. Mrs. Alice Olley and Mrs. Melanie Horrigan

2. Public Representations.

Mr. George Smith. Mr Smith asked how the Parish Council will engage with the District Council over the proposal in the Local Plan to build 41 houses in the village. He added that, whilst no details were yet available as to where the houses would be built, in his opinion, it was very important that the Parish Council engages with the District Council over this matter. There will be an open consultation in the Town Hall, Saffron Walden on Tuesday 14th November 5-8pm. which he urged members to attend.

Councillor Mrs Lee asked why Ashdon was designated to have 41 houses when other villages in the area of similar size and with similar facilities would not. Mr. Smith said he could not give a definite answer other than Ashdon had been designated a "principle" village and that Ashdon was the only village in the immediate area to have had a site offered by a local land owner in the "call for sites". Councillor Foley said that it was important that Ashdon take part in the consultation and that in his view, the allocation of 41 houses was not acceptable.

Councillor Ms. Gray added that the Neighbourhood Watch Group would be making representations to the consultation.

3. Short Address by Councillor Foley on County Council matters

Councillor Foley reported that a new County Council Cabinet Member, Cllr. Tom Cunningham, had been appointed as member with the Highway portfolio. He hoped that progress on outstanding matters including Radwinter Road would now be progressed. It is his intention to invite Cllr. Cunningham to a site meeting to bring him up to speed on outstanding Highway matters in the village.

The Draft Local Plan was now out and a consultation would be held as reported by Mr. Smith. The number of properties in the wider district had been reduced due to the proposed 1200 houses at the old Easton Airfield now called Easton Park, The final Plan was still a long way off. He reminded those present that there hadn't been a "Local Plan" since 2005 which had given rise to a "developers charter" in the District.

Cllr. Foley said that a schedule for drain clearing was required from the County Council for Radwinter Road. In response to a question from the Chairman regarding drainage from the building site "Bourn Vale," he said that the Parish Council should

write to Nigel Browne, Development Manager at the District Council copying in Dean Hermitage, Head of Planning, to bring the outstanding drainage matters to their urgent attention.

4. Short Address by Councillor Moran on District Council matters.

There was no address from Councillor Moran.

 - a. Rectory Lane. The two "spurious" benches had been removed. Still waiting for Andrew Everitt's advice on the access from Ladywell
 - b. Church Field. Mr. Chris Pardue would organise moving the new bench away from the fence.
- ii. Highways: Traffic Management.
 - a. Report on decision of the Local Highways Panel. Condition of the gulleys in Radwinter Road, Crown Hill and Water End. See Item 3. Cllr Foley's Report
 - b Speeding and Highway Matters. See Item 3. Cllr. Foley's Report. The provision of a 20mph blanket speed limit in the county would not now be put in place.
 Flashing Speed Signs. The Chairman would obtain quotations and would seek a site meeting with Sarah Tomlin, Highways, to see first hand the problems in Radwinter Road, the suggested siting of speed reduction signs and discuss the possibility of placing speed reduction signs on existing poles. Cllr Foley would also continue to investigate the possibility of a 40mph limit at the entrances to the village previous to the existing 30mph limit.
- iii. To receive an update from Cllr. Mrs. Lee on the roadworks at Linton

Cllr. Mrs. Lee reported that the new roundabout at Linton was now in operation and improvements were underway at Dean Road Crossroads. She

had attended a Speedwatch meeting and was trying to get the village Speedwatch Group reinstated. Several people had volunteered but more were required.

Councillor Foley left the meeting at this point.

- iv. Potential grants for the Village Hall/White Horse House would be added to the Agenda for the next meeting.(Cllr. Ms. Gray)
- v. Community Led Housing. It had been reported that Highways were not happy with the entrance to the site adjacent to All Saints, the Parish Council were now waiting to hear from the District Council on this matter.
- vi. Neighbourhood Watch. Nothing to report
- vii. Allotments. Mr. Malcolm McGeoghan, owner of the Allotments, had been in correspondence with the Chairman regarding the possibility of the Parish Council leasing the Allotments in toto. He had suggested an annual rent of £1000.00, £500.00 for the allotments currently in use and £500.00 for the unused area.

Resolved – that the Chairman asks Mr. McGeoghan for a meeting to discuss the possible leasing of the Allotments by the Parish Council and to determine the responsibilities for the hedges, river bank, trees, culvert etc. (Cllr. Elsey)
